### Estimate your individual accreditation fee in only 2 steps!

STEP 1: Select the accreditation program for your organization by confirming that you satisfy the program's prerequisites

1. Quality in Dental Care
Prerequisites for Quality in Dental Care accreditation:
$\Box$ Conduct business as a <b>licensed</b> healthcare provider in your country for at least one completed financial year.
$\square$ Manage dental and non-clinical services with a <b>Continuous Quality Improvement</b> system.
☐ Your organization's practices are in accordance with <b>international standards of medical ethics</b> , as stated in the World Medical Association (WMA) International Code of Medical Ethics.
If you have ticked all 3 boxes, you are eligible to apply for "Quality in Dental Care" accreditation. If not, please contact us to review your options.
2. Excellence in Dental Tourism
Prerequisites for Excellence in Dental Tourism accreditation:
$\Box$ Conduct business as a licensed healthcare provider in your country for at least one completed financial year.
$\square$ Manage dental and non-clinical services with a <b>Continuous Quality Improvement</b> system.
☐ Your "International Patient Department" offers comprehensive services including: pre-travel, on arrival, inpatient treatment, discharge, and post-treatment follow-up.
☐ Manage international patients for at least two years.
$\square$ Assure <b>24/7 access to multilingual</b> staff (or interpreters) for patients and relatives.
$\Box$ At least 10 % of your patients are regional (travel within the country or cross nearby borders to receive treatment) and/or international patients.
☐ Your organization's practices are in accordance with <b>international standards of medical ethics</b> , as stated in the World Medical Association (WMA) International Code of Medical Ethics.
If you have ticked all 7 boxes, you are eligible to apply for "Excellence in Dental Tourism". If not,
