STEP 1: Select the accreditation program for your organization by confirming that you satisfy the program's prerequisites

1. Quality in Reproductive Care

Prerequisites for Quality in Reproductive Care accreditation:
☐ Conduct business as a licensed healthcare provider in your country offering reproductive care services according to national law for at least one completed financial year.
$\hfill\square$ Manage reproductive care and non-clinical services with a Continuous Quality Improvement system.
\square Cooperate with an affiliated hospital in case the fertility clinic is not located in a hospital.
☐ Your organization's practices are in accordance with international standards of medical ethics , as stated in the World Medical Association (WMA) International Code of Medical Ethics.
If you have ticked all 4 boxes, you are eligible to apply for "Quality in Reproductive Care" accreditation. If not, please contact us to review your options.
2. Excellence in International Reproductive Care
Prerequisites for Excellence in International Reproductive Care accreditation:
\square Conduct business as a licensed healthcare provider in your country offering reproductive care services according to national law for at least one completed financial year.
\square Manage medical and non-medical services with a Continuous Quality Improvement system.
\square Your "International Patient Department" offers comprehensive services including: pre-travel, on arrival, inpatient treatment, discharge, and post-treatment follow-up.
\square Manage international patients for at least two years.
\square Assure 24/7 access to multilingual staff (or interpreters) for patients and relatives.
\square At least 10 % of your inpatients are regional (travel within the country or cross nearby borders to receive treatment) and/or international patients.
\square Cooperate with an affiliated hospital in case the fertility clinic is not located in a hospital.
☐ Your organization's practices are in accordance with international standards of medical ethics , as stated in the World Medical Association (WMA) International Code of Medical Ethics.
If you have ticked all 8 boxes, you are eligible to apply for "Excellence in International

Reproductive Care". If not, please contact us to review your options.
